If you sign up for all 4 dates by the due date, you receive a discount - total due will be \$100. (Cash, check or credit card). No refunds under any circumstances.

No street vendor is registered until all forms and payment are received at the Chamber Office and you have received a confirmation email from Lisa Cochran, MainStreet Director.

Along with the confirmation email you will receive the Vendor Guidebook which has details regarding our Downtown Thursday event. *The Friday before each event*, participants will receive a map listing the locations of businesses, food vendors, street vendors, and entertainment. It will also include any last-minute updates.

In consideration of payment, MainStreet Owatonna agrees to provide a space for vending at the Downtown Thursday event(s) circled above. Location to be assigned upon contract approval. MainStreet Owatonna reserves the right to refuse to accept any vendor who, in the sole judgement of MainStreet Owatonna, does not meet the standards of decorum of Downtown Thursdays.
