While the process of creating the brand is complete, the implementation is far from done. Partner organizations will be redesigning websites over the next few months to integrate the brand, seasonal digital marketing campaigns will kick off throughout the state and region this spring, billboards are secured, and new visitor guides will soon be delivered. Over the next two years, the branding will continue to be integrated within our typical marketing plans. You will continue to see special initiatives promoting Owatonna as a great place to visit, work, own a business and live! Videos, tradeshow materials and additional marketing will continue to be developed as part of the 2024 roll-out of the community-wide brand.

Learn & Earn Approved

The Minnesota Department of Employment and Economic Development has approved the Chamber Foundations plans for the \$1M legislative appropriation. The funds will purchase advanced manufacturing equipment for both Owatonna High School and Riverland Community College - Owatonna. Additionally, about \$100k of the dollars will support the creation of the Owatonna Opportunity scholarship fund.

City Council Discusses Facility Needs

The city council is having serious conversations about facilities. Specifically, around what to do regarding an emergency management facility (police, fire) that will situate the departments for the future. Secondly how to tackle the ever-growing desire

of the community to have a community center. The chamber policy committee attended a recent council study session where consultants outlined some preliminary facility items for discussion.

How past decisions are impacting Owatonna Today

It would've been impossible to understand how the decision by Cybex



over a decade ago to build a new, state-of-the-art facility in Owatonna would impact the company's fate in Owatonna today. The company has been purchased since the new building was built. It is now Life Fitness and because the facility and workforce are so solid here, the company has moved work from other facilities around the country to our community. Something that most likely would NOT have happened if they didn't make that significant investment.



Conference space available for member use

The Chamber recently remodeled the conference space in the new building. There's seating for 20 comfortably. Kitchenette, refrigerator, and coffee makers are available. As a member, you can reserve time to use this space at no cost.

Next steps at Chamber building

The Chamber Board has approved additional work on the new building at 120 S. Oak Avenue. This spring the exterior will get a new coat of paint and new signage.

Explore Minnesota Tourism unveiled livability campaign at February's conference


Explore Minnesota's livability campaign highlights recent transplants from other states to Minnesota focusing on their choice to move here because of job opportunities, high standard of living, and a great place to raise a family.

The ads in the new "Star of the North" campaign, aim to draw more visitors and new residents, launched March 4 in 22 states and Canada.

This is the first time Explore Minnesota is marketing beyond tourism, hoping to inspire Americans to consider relocating to Minnesota, with digital, TV and radio ads targeting communities such as Seattle, Boston and Austin, Texas. Separate tourism ads will air mostly in the Midwest as well as cities including Denver and Dallas.

\$11 million of the new state funding to Explore Minnesota is dedicated to starting a new division called Explore Minnesota for Business, focused on economic development. The first phase is focused on attracting residents, followed by campaigns to bring new businesses and encourage students to stay in Minnesota for college and after graduation.
